# **Workgroup Purpose**

- Identifying areas of service expectation and potential uniformity for QRTPs that could be incorporated into purchaser & provider contracts; and
- Exploring opportunities for joint advocacy designed to improve service capacity, funding, and the continuum of care for children in both community and out-of-home care settings.

#### Workgroup Learnings & Recommendations

Barriers to serving children and families are multi-faceted.

- Resource Shortages
  - Operational Capacity RCC "licensed beds" may be similar to 10 years ago, but "staffed beds" and shared rooms are fewer due to shifts in practice
    - Trauma-informed care; agencies moving from double-occupancy to single; challenges recruiting qualified staff to work with children in need of <u>treatment</u>
    - Lower levels of care not properly resourced driving kids into deeper end of the system.
    - Lack of childcare is placing additional constraints on the system.
- We Can Partner to Effect Change
  - Joint advocacy for a Psychiatric Residential Treatment Facility

### Workgroup Learnings & Recommendations

- Shifts in the Field
  - Trauma-informed care
  - Family First TIC Model, evidence-based/informed interventions, clinical need for service
  - DCF Child Welfare Transformation moving from "placement" to "short bursts of treatment", prevention, family and like kin, 5% reduction in group care, resource homes.
- The way we communicate matters
  - Providers communicating with others about their unique program delivery
  - How we talk about one another is important we are partners
  - Uniform Addendum for Qualified Residential Treatment Programs & SYNC

# Workgroup Learnings & Recommendations

- Workforce
  - Significant turnover and green staff
  - We all do things differently each provider, each county or other purchaser (of which there are many), AND each individual worker
- Partnership Improvement Strategies
  - $\bullet$  There are things we can do now (see pages 10-12 of the report)
  - · Relationships matter!
  - Talk, share power, and respect everyone's unique expertise child, family, case managers, clinicians

#### Recommendations

### Resource Shortages, Financing, Partnership Improvements

- Joint advocacy for things such as the creation of a Psychiatric Residential Treatment Facility in Wisconsin.
- ✓ Requests for the Department of Children and Families (DCF) and the Department of Health Services (DHS).
- Developing tools, such as a uniform Addendum for Qualified Residential Treatment Programs that each provider will complete.
- Creating a more formalized process for ongoing WCHSA/WAFCA partnerships.
- ✓ Fund a position dedicated to overseeing the change process and advocacy needs for 1-2 years.
